**ADDENDUM NUMBER III TO AGREEMENT BETWEEN THE NORWEGIAN AGENCY FOR DEVELOPMENT COOPERATION AND DET KONGELIGE SELSKAP FOR NORGES VEL (NORGES VEL) CONCERNING POVERTY REDUCTION THROUGH BUSINESS DEVELOPMENT AND FORMAL COOPERATION, QZA -19/0271.**

**1 BACKGROUND**

- 1.1 The Norwegian Agency for Development Cooperation (Norad) and the Grant Recipient (jointly referred to as the Parties) have entered into an agreement dated 31 March 2020 (the Agreement) as amended by addendum number 1 dated 30 June 2021 and addendum 2 dated 12 October 2021 concerning QZA-19/0271 Poverty reduction through business development and formal cooperation (the Project).
- 1.2 The Grant Recipient has submitted requests to Norad, concerning activities in Tanzania dated 8.09.2022 and concerning activities in Madagascar and Mozambique dated 20.10.2022, regarding additional financial support to the Project, with which Norad has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number 3 (the Addendum), which shall be an integrated part of the Agreement.

**2 ADDITIONAL GRANT**

- 2.1 Norad shall, subject to Norwegian parliamentary appropriations and on the terms and conditions of the Agreement and this Addendum, provide an additional grant not exceeding NOK 17 305 045 (Norwegian Kroner seventeen million three hundred five thousand and forty-five) (the Additional Grant).
- 2.2 The Additional Grant shall be used exclusively to finance the Project as specified in the budget attached as Annex A to this Addendum during the Support Period.
- 2.3 The Additional Grant shall be disbursed upon written request as described in the Agreement.

**3 REMAINING CONDITIONS OF THE AGREEMENT**

- 3.1 All other provisions of the Agreement shall remain unchanged and in force.

**4 ENTRY INTO FORCE AND DURATION**

- 4.1 The Addendum shall enter into force on the date of the last signature and remain in force until all obligations arising from it have been fulfilled.
